##### Scope of Work

##### 1. Background

Sindh Irrigated Agriculture Productivity Enhancement Project (SIAPEP) is seeking services of a qualified Vehicle Tracking Firm to ensure effective fleet management system.

##### 2. Methodology

Vehicle Tracking firms need to submit comprehensive tracking methodology and implementation mechanism in order to mature the purpose of this procurement relate to installation of trackers (on rental basis) on SIAPEP vehicles. Firms need to provide detailed specification of their tracking services. The successful firm shall be tasked to carry out the assignment for twenty (20) vehicles at different locations of Upper & Lower Sindh. This assignment would be for twelve (12) months.

## Section II: Important Notes:

Firms must pay due attention to following points. In case of non-compliance, the offer can be considered as non-responsive:

- Offer must be valid for Thirty (30) days from the date of the bid deadline.
- Firms must accept the payment condition i.e. monthly payment will be made to the successful firm against in PKR within thirty (30) days after acceptance of invoice by the purchaser.
- Conditional offer/bid is not acceptable.

## Section III: Vendor Offer Evaluation

SIAPEP shall first examine the vendor's proposal in respect of their understanding about the requirements of the required services in accordance with TOR. Particular attention shall be given to their approach, methodology of work and level and extent of their proposed personnel inputs. Firms are encouraged to provide maximum input and information while submitting their bids. For evaluation, following points shall be considered:

- Price
- Experience
- Relevant experience of the firm related to the specific assignment
- Adequacy of the proposed work plan and methodology in responding to the TOR
- Presence in Sindh province.

## Section IV: Instructions

### **SEALING & MARKING OF BIDS:**

- The firm shall seal the original and each copy of the bid in an inner envelope, duly marking the envelope as "Original" or "Copy". The inner envelope shall then be enclosed in an outer envelope. In the event of discrepancy between them the Original shall prevail.
