Bidders should quote the DDP Price to all the offices of Twenty-four (24) districts of Sindh Province/warehouses of concerned NGOs in all districts. If the final destination is different from the named place of destination for DDP, the Purchaser will pay the Supplier the reasonable costs for inland transportation, insurance, and other local services required to convey the Goods from the named place of destination to their final destination (Project Sites). Bidders shall arrange /hire /use their transportation /carriers and labor to deliver the Kitchen Garden Kits and ensure unloading at the offices of Twenty-four (24) districts of Sindh Province/ warehouses of concerned NGOs in all districts (Details of final destination/project sites/mentioned on pg. 16 (ITB clause 14.7), Pg. 35 (Section-II Bid Data Sheet of the bidding document).
