- The Government of Islamic Republic of Pakistan has received a credit from the International Development Association (IDA) for Sindh Irrigated Agriculture Productivity Enhancement Project (SIAPEP) to be implemented in the Province of Sindh and applying part of its proceeds for payments to the farmers/ service providers for provision of Laser Land Leveling Equipment.
- 2. The project has delivered 1290 laser units up to June 30, 2018 and envisaged the provision of additional 500 Laser Land Leveling Equipment to the farmers/ service providers for the remaining project period i.e., up to December 31, 2022. The interested firms will be Pre-Selected as Supply and Services Companies (SSCs) upon meeting the approved standards and specifications set out for Laser Land Leveling Equipment to be provided under the project.
- 3. The Expression of Interest is invited from eligible firms/ consortium/ joint venture with specific and proven competence and experience in supply of complete Laser Land Leveling Equipment and provision of post-delivery services to indicate their interest. Eligible firm(s)/joint venture(s) should submit their applications in English language along with relevant complete details to enable SIAPEP to prepare a short list of eligible firm(s)/joint venture(s) for participation in subsequent proceedings of the project as supply & service companies.
- 4. The firm(s)/ joint venture(s) having the prescribed minimum requirements mentioned at para 7 below would be eligible for pre-selection under the scheme for the project period. The firms already pre-selected for this assignment under SIAPEP are advised to re-apply in the process.
- 5. The Firms / Suppliers / Joint Ventures can download the details of Approved Standards and Specifications from the Project website www.siapep.org/procurement/ The clarification if any can be sought in writing through email or by letter addressed to Project Director, SIAPEP, Hyderabad at least 10 (ten) Days before the closing date.
- 6. The complete applications along with two (02) sets of required documents must be submitted in the office of Project Director, PIU, SIAPEP, Hyderabad on below address on or before <u>June 20, 2022</u> by 5:00 PM.

- 7. Supply & Services Companies (SSCs) must have minimum requirements such as below. Any misrepresentation of facts/ provision of fake documentation/evidences or violation of below requirements is liable to sanctions and debarment:
 - I. Should be Tax Registered and able to undertake documented transactions.
 - II. Agrees to the method and amounts of applicable tax.
 - III. Must have an office in Pakistan.
 - IV. Can provide the equipment of the specifications as stated to SIAPEP website
 - V. Will ensure booked delivery within minimum time frame, not exceeding 2 months.
 - VI. Must have minimum average annual turnover of Rs. 10 million during last three financial years.
 - VII. Must be manufacturer, sole distributor and/or authorized dealer of specific make of Laser Land Leveling equipment (attach valid certificate). The Firm(s) may enter into joint venture (JV) to strengthen its capability to provide the requisite services for the purpose.
 - VIII. Must provide affidavit confirming that the applicant firm / joint venture is not blacklisted/debarred in PPRA/SPPRA/World Bank.
 - IX. Has enough inventory/stock of PLL units and/or verifiable arrangements with vendors for timely delivery
 - X. Must have experience of providing at least 30 LASER units in public/ private sector during the last five years (attach year-wise list of purchasers/ beneficiaries with name, complete address, phone/fax, and date of delivery). Any additional document may be furnished to support relevant experience of firm(s)/Joint Venture);
