Terms and conditions for acquiring the subsidy based Deep Ripping Equipment:

- i. I own a tractor (not less than 55 HP) compatible to the Deep Ripping Equipment.
- ii. I shall acquire the Deep Ripping Equipment from one of the identified supplier firm, listed for this purpose by Project Director-Project Implementation Unit (PD-PIU), Sindh Irrigated Agriculture Productivity Enhancement Project (SIAPEP).
- iii. If, I would not be able to book / purchase Deep Ripping Equipment with any identified supplier firm within thirty (30) days of time frame after the balloting, the PD-PIU SIAPEP keep the right to award to the next in waiting list also chosen by ballot.
- iv. I shall abide to follow the payment procedure and pay the due share within the specified period in favor of chosen Supplier Firm.
- v. I ensure to carry out Deep ploughing / cultivating of my own land, would provide such services on rent to other farmers and use the Deep Ripping Equipment solely for agricultural purpose to achieve a minimum of 240 acres per year.
- vi. I shall keep the record of Deep Ripping Equipment usage and maintain the log book provided by PD, PIU, SIAPEP and would provide details to PD-PIU-SIAPEP or his Representatives time to time. Also, I would provide names and holdings of farmers whose Deep ploughing / cultivating with a statement of receipts and expenditure relating to the Deep Ripping Equipment.
- vii. I will never sale, transfer or hand over possession of the Deep Ripping Equipment at least before two years of use to any person / party.
- viii. I would bear full operational and maintenance cost of Deep Ripping Equipment.
- ix. I ensure to arrange one Tractor Operator to be trained by the Department.
- **x.** Ensure that neither I have availed such facility of subsidized Deep Ripping Equipment from the Provincial / Federal Organization.
- **xi.** I undertake that if my application is rejected during scrutiny, then I would abide by the Scrutiny / Allotment Committee decision and would not challenge in any court of law.
- xii. I undertake that I will bound and will never violate the terms and conditions for acquiring subsidized Deep Ripping Equipment through project scheme, if so I will be liable to pay back full amount of financial assistance to the Government of Sindh.

Important Instructions:

- Application forms for acquiring subsidy based Deep Ripping Equipment are available with free of cost at all SIAPEP / On Farm Water Management (OFWM), District Offices. Photocopies of the application forms are also acceptable. Application forms may be downloaded from the **official website:** www.siapep.org.
- ➤ One time applications are invited to provide Deep Ripping Equipment for the total yearly target to support the farmers / service providers/ recipients.
- ➤ The Allotment Committee constituted by the Project will scrutinize applications of farmers/service providers on the basis of setout criteria. The allotment based on balloting among all the eligible applicants for the quota of their respective Districts may participate in the balloting process which will be initiated through concerned Deputy Commissioners at each District Headquarter. The list of successful / unsuccessful applicants will be put on display outside the office of the SIAPEP / On Farm Water Management at each District and also the same will be uploaded on the official website.
- The successful applicants will negotiate the price, delivery time and will pay their share of the total cost in shape Demand Draft in favor of chosen supplier to the office of Project Director, PIU, SIAPEP, Hyderabad within one month of the date of award. In case of failure in meeting the deadline the award will go to the next in waiting list, also chosen by ballot.
- The Project's contribution to the total price per unit will be i) PKR 67,500 or ii) 45% of the purchase price whichever is lower.
- ➤ The financial assistance will be provided under SIAPEP to the concerned supplier, after verification of the quality of the supplied equipment by the Inspection Committee of the Project and equipment delivered to the service provider/grower at Agriculture Engineering Workshops, Tandojam / Thatta / Sukkur / Larkana / Khairpur.
- In case of violation of any term and condition by the beneficiary at any stage, Project Director-Project Implementation Unit (PD-PIU) will take punitive action against the beneficiary, which may include cancellation of Deep Ripping Equipment allotment and / or recovery of the amount of financial assistance as arrears of land revenue.
